AHE 375: Diversity in Higher Education

LITERATURE REVIEW

A literature review is a comprehensive analysis of sources related to a specific research topic. The goal of this assignment is to locate a range of sources and synthesize them in order to address one's inquiry question related to a diversity, equity, and/or social justice issues within higher education.

Example Topics:

- Supports and barriers for transgender faculty at postsecondary institutions
- Use of transformative feminist pedagogies in enhancing the curriculum
- Challenges for Asian Americans and Pacific Islanders in higher education
- Retention of black male students in predominantly white institutions

Paper Guidelines:

- Submit a minimum of 5 pages (this does not include your works cited page) that provides relevant information related to the selected topic; this includes but is not limited to defining terms, sharing related history, or addressing the gaps in the research.
- Include a clear and concise inquiry question and thesis statement that drove your research.
- Incorporate at least 10 sources (minimum of four peer-reviewed sources) that relate to your selected inquiry question.
- Organize your literature using one of the following formats: chronologically, by publication type, by themes, or by research methods:
- Follow APA format: 12 font, Times New Roman, 1" Margins, Double-Spaced

Presentation Guidelines:

- Give a 10 minute presentation that provides relevant information related to the selected topic; this
 includes but is not limited to defining terms, sharing related history, or addressing the gaps in the
 research.
- Submit via Canvas a works cited list on the day of your presentation.
- Refer to at least 10 sources (minimum of four peer-reviewed sources) that relate to your selected inquiry question in your presentation as well as your works cited list.
- Organize your presentation using one of the following formats: chronologically, by publication type, by themes, or by research methods.
- Include presentation slides to guide and engage your audience

Remember, a literature review is not a summary of sources, but rather a conversation between sources. This "conversation" should demonstrate that you critically analyzed and evaluated your sources and saw connections between the arguments and information presented by each author.
